FY24 Changes

- May be a few additional as the Department works through changes made in state budget
- Some final, some still be developed and put out for public comment- manual changes are final word
- May also have changes related to reports and other non-EMIS manual items

At Student Entry

- 24-116: Count of graduation credits at entry
- 24-75: Program codes for non-public student competency
- 24-60: Program codes for entering kindergartners



24-116: Count of graduation credits at entry

- Information used for the report card
- Two groups of students
 - Students new to your district- how many credits earned when they enroll in your district
 - Students continuing from prior year- how many credits earned as of the first day of the current school year
- Tried to use cumulative GC records, but data not complete enough
- Measure compares new students vs. continuing

24-75: Non-public student competency

- Adds 2 new program codes- one for math, one for English
- Applies to students pursuing graduation under FY23 and beyond requirements
- Information on required Iowa and Terra Nova competency scores found on ODE graduation web pages
- Different from reporting these tests as an EOC replacement- for FY22 and prior graduation requirements
 - Score not reported with score as graduation points
 - Not needed for FY23 and beyond students

24-60: Program codes for entering KG

- Optional for FY24
- Required in EMIS law (3301.0714)
- Do the best you can- in some cases, have to rely on input from parents
- Set up systems now to collect at KG enrollment in spring

Reporting enrollment

- 24-103: Intradistrict Enrollment
- 24-82: Updates withdrawal reporting guidance
- 24-63: Updates to Percent of Time for PK/KG
- 24-33: Updates to expulsion reporting

24-103: Intradistrict enrollment

- Not a change in data collected
- Make sure you are accurately reporting **Attending** vs. **Assigned** building IRN
- School choice within district?
- Placement for special programs?
- Will likely be used for reports to legislature

24-82: Withdrawal reporting guidance

- When a student withdraws, reason and date will rarely change
 - Only if later discover enrollment in another entity **before** you withdrew the student
- If learn further information that is effective after original withdrawal date and before end of current FY reporting, report as updated exit reason
- If after current FY reporting, use override next year

24-63: Percent of Time for PK/KG

- All KG students must be on a full time calendar
 - Use percent of time if less than full time
- For preschool, now use 910 as a minimum for a full time calendar
- Use percent of time to reflect how often student is expected to attend

24-33: Updates to expulsion reporting

- No longer immediately report expulsion as a withdraw
- If providing services, keep a district relationship of 1, zero regular percent time, and report a sent to percent of time
- If not providing services, set to district relationship of 3 and zero percent of time
- At end of expulsion (or start new school), move back to regular enrollment or report appropriate withdrawal
- Carry-over from last year

24-73: Literacy Instruction

- Report materials used from TBD list
- DN attribute
- More to come!

24-67: Collecting reading diagnostics

- Now report the actual reading diagnostic given along with a score or result
- Assessment will be reported in a new collection
- Only report first result
- A student is only exempted if on the alternate assessment- we will use IEP data to determine
- An FAQ with additional aids is being developed
- Likely to be some type of level 2 report, but still in discussion phase

24-13: Reporting dyslexia screening

- For Tier 1, report assessment record and score/result
- Assessment will be reported in a new collection
- For Tier 2, a new FN element
- An FAQ is being developed to assist with reporting
- Many students required to be screened and reported this year, but number will decrease in future years
- Likely to be some type of level 2 report, but still in discussion phase

Other Changes

- 24-101: CTE at Ohio Technical Centers (OTCs)
- 24-62: Adds KG survey data to EMIS
- 24-53: Collect district software

24-101: CTE at Ohio Technical Centers

- New option provided by state budget
- Development still underway, but likely
 - A new delivery method for all courses
 - A new sent reason for some students
 - Reporting a sent to percent of time for some students
- Students will be able to generate more than 1 FTE if the OTC course takes a student beyond the hours in their assigned calendar

24-62: Adds KG survey data to EMIS

- Survey preciously completed by districts
- Some items will now be derived based on enrollment data
- Other items will be reported as DN attributes
- Only reported in the first S enrollment window

24-53: Collect district software

- Will help ODE know who may be impacted if a vendor has an issue
- Collection for SIS, HR, and Finance packages
- Only report primary software in each group
- Update if there is a change in the primary software used
