Jaheeyowkun may kiinsheegey wal quseeya haquuqoogaas. iskoolkaa may laku fathey inii kisiyi koobiga jaheyowkun hal jeer sanna kasta onogaa hela atheegoo Walbarashada qaaske eh. May sidoo kala lakoo fathey inii atha hela koobiga:

- Haddii atha warsata inii onogaa la qiimeya sababtoo eh may an maleyey inii onogaa qobo naafanima;
- Haddii iskoolka degmathaa fathow inii onogaa la qiimeeya sababtoo eh may an maleeyeena inii onogaa qobo naafanima;
- Haddii atha hareyta (gudbi) *Ashtako* - oo qoraal haan eh - oo la jaraan Hafiiska Ardayda Qaaske eh ee Laanta Walbarashada Ohio, oo eta *abashadaa* koowaad ee sanna dugsiyeedka;
- Haddii atha hareyta (gudbiitha) odsa - qoraal haan eh - ii Hafiiska Ardayda Qaaske eh ee Laanta Walbarashada Ohio oo *dhugunsuga adaalada shariga* ee la hiriira Walbarashada onogaa, oo may buwaa markii anka horeyti ee sanna dugsiyeedka oo atha warsata too;
- Haddii onogaa *lanku biyi iskoolka sababoo edbiyowka (dabee'ada)* - oo onogaa marhora laku biyi iskoolka oo 10 gee eh ama ku bathan intii laka jari sanna dugsiyeedka hatta; ama

Ogolaanshaga Waalidnimatha La ogeysiiyi

Ogolaanshaha waalidnimatha la ogeysiiyi may buwaa inii atha/ama degmatha an maga'awti waalidka ku meel deerowka, oo qoraal haan, oo iskoolka degmatha inii suubitha tallaaba. Ogolaanshagaa sithoo kala may buwaa inii degmatha ka siitha aqbaar quseyta tallaabada la hajeethiyi. Iskoolka degmatha onogaa may buwaa inii atha kiin ku hela ogolaanshagun, qoraal haan, oo suubiyow walyaalaga qaarshoo oo la hiriiraan Walbarashada qaaska eh ee onogaa. Iskoolka degmatha may buwaa inii hela ogolaanshagaa oo qoran:

- Ku hor intii degmatha anku qiimoyna onogaa waqtaga koowaad si lan ogaatha Haddii onogaa an baahanyi Walbarashada qaas eh ii atheegoo la hiriiraan;
- Ku hor intii degmatha an bilaabna siiyowka onogaa atheegoo Walbarashada qaaske eh ee ka qoran barnaamijshay ama barnaamijkiishee Walbarashada la gaareyi ee an ka horeeyn, saas oo kala lan ka saw IEP;
- Ku hor intii degmatha an qiimoyna onogaa si lan ogaatha Haddii baahiyatha onogaa isbadeleen;
- Ku hor intii degmatha anka suubina onogaa baarow dheeraad eh. Tusaalaga may naqatheey Qiimeeyowka Shaqada Dabee'ada;
- Ku hor inta degmatha an badelna meeleyowka Walbarashada onoga. Tan mi'nasheey ma eh isbadelowka meela. Badelshee, may la mi'na etaa badalka barnaamika Walbarashada onogaa; ii
- Ku hor intii degmatha an siina aqbaar onogaa quseyta qof an hayna haan ku qoran shariga gobolka ama faderaalka.

May la ka jeeda Waalidka Wakiilka eh?

Waalidka wakiilka eh may buwaa shaqsa laku yaaba inii matala onoga naafatha eh oo arimoo dhan eh oo la hiriiraan an qalamowka ii helowka atheegoo Walbarashada qaaske eh.

Iskoolka degmatha oo meela atha ka noola may may an hilsaaraayaana waalid wakiil markasta oo haan ha dareeraan dhiyaan:

- Waalidka mal aqoonsatha kara;
- Iskoolka degmatha, dathaal ma'quul eh ku dib, ma weydiyi koraan waalidka;
- Onoga may ka jaree dhalinyaratha guri la'aanta lan la jarna; ama
- Onoga may buwaa qeeb ku kid eh gobolka.

Ogolaanshaga Waalidnimatha La ogeysiiyi Mal an Baahan Markii Haan Ha dareeraan Midshoo Dhiya:

- Degmatha may fdiiriyowtee aqbaarta kutaabta hor an jarti sitha qiib ku eh nithaamka qiimeeyowka/reed an qiimeeyowka; ama
- Degmatha may la suubiyaase qiimeynatha onogaa oo laka maamuli kutaabta oo dhan.



Si lan kiin siyo Ogolaanshaga Waalidnimathaa La ogeysiyi, Degmatha:

- May laku fathey inii hubiitha inii isti'maali afka asalka eh, ama qaab kala ee hiriir atha fahamaasa, si la kin siiyi aqbaarta atha an baahanta oo dhan may lakoo fathey inii go'aan atha suubitha;
- May lakoo fathey inii atha hubiitha inii atha fahamti oo atha ka ogolaati qoraal haan oo degmatha ka suubiyaasa hoola ii ogolaanshagaa may sharaheey hoola, saas oo kala diiwaana kasta oo onogaa eh oo lala wathaagow dadka kala oo;
- Waa inii hubiyaan inii atha fahamti inii atha siiyaasaa ogolaanshagaa iqtiyaarkaa qaaske eh oo badela korto maskantaa waqta kasta;
- Waa inii hubiyaan inii atha fahamti in Haddii atha ku noqota ogolaanshagaa, degmatha mal an baahan inii ha nagaan tallaab kasta oo qaathati inta an dhaheyta waqtaga atha siitha ogolaanshaga ii waqtaga atha ku laabati.

Ku laAshtako Ogolaanshaga

Ku laAshtako ogolaanshaga may la mid etaa inii la laabata ogolaanshagaa. May ku laabatha kortee ogolaanshagaa waqta kasta Haddii atha go'aansata inii atha markala an fathaana inii onogaa hela atheegoo Walbarashada qaaske eh sithii laka biyi IEP-ga onogaa. May la koo fathey inii tan ka suubitha **qoraal haan**.

Kudib, iskoolka degmathaa:

- May laku fathey inii roojiya siismatha onogaa atheegoo Walbarashada qaaske eh ee IEP, laakin ku hor intii an roogsana siismatha atheegoo, degmatha may laku fathey inii kii siiyaan ogeysiinta qoraal haan oo eh inii roojiyaayaan atheegoo. Ogeysiinta degmatha ka siiyaayaan may lan kasey ogeysiinta qoraalka ku hor. Ogeysiintun qoran ee hora may laku fathey inii buyta sharuuthoo laka dajiyi qiibta Ogeysiinta Qoraalka Ku hor ee baalka 9 ee jaheeyowkun.

Markii degmatha ka siitha ogeysiintun qoraalka ku hor oo sheegaw inii markale an siiyaan atheegoo Walbarashada qaaske eh onogaa ii markii atheegoo surumaan, degmatha markala ma tihgeliyaasa inii onogaa an qalama Walbarashada qaaske eh oo may badelshey an tihgeliyey onogaa kutaabka Walbarashada guud.



Si atha an ka qalanta may si futhud lan ka jeethee inii onogaa laku ogaathi inii an baahatha atheegoo Walbarashada qaarshoo sababtoo eh halkoo ama naafanimatha badan. Shaqsiyaadka qobaan Heerka Walbarashada Naafanimatha (IDEA) may an baahanyiin kutaabta naafatha eh inii helaan ta'liin kaas eh ii/amaa atheegoo la hiriiraan. Si lanka tihgeliyi kutaabka naafatha eh sitha quseyta sharigun, onagaa may buwaa inii an baahatha ta'liin kaas eh ii/ ama atheegoo la hiriiraan sababtoo eh naafa nimathisa ama naafanamthiyee oo halkoo ama ku badan oo qiiboo naafanimatha higaan:

- Naafanimatha aqliga;
- Naafanimatha dheegowka;
- Naafanimatha hadalka ama afka;
- Naafanimatha araga;
- Dhibaataatha shucuurta;
- Naananimatha qaliinka murqoo;

- Naafanimatha Walbarashada qaaske;
- Aamanimatha;
- Aamanimatha-amoolaga;

Afka Dhaladka ama Noo' Kala oo Hiriir eh

Kulushoo kulumoo atha ku qiibgali, qiimeynta onogaa oo kulushoo ogeysiinatha atha heli may la fathey inii ka qoranaata ama an ka hathala afka atha an dhalati ama noo' kala oo hiriir atha isti'maala.

Kulushoo imtihaamatha ama qoraalatha kala oo lan isti'maali inii laka qiimeeya onogaa may la fathey inii haata afka salka onogaa — ama qaabab kala oo hiriir oo siiyaasa degmatha aqbaar sahan ee walaagii onogaa kasaw oo aqoon haan an suubiya koro, hormar haan ii shaqa haan, illaa si ed an ka muuqana inii siitha ama maamula.

Warsooy Degmatha inii Qiimeyto Onogaa

Haddii atha an maleyti inii onogaa qobo karo naafanima oo saameeyaasa ta'liintiisa ama ta'liintiyee, may warsatha kortee inii degmatha qiimoyta onogaa si an go'aansathan haddii usa ama iyee an qalama koraan Walbarashada qaaska eh (la tihgeliyi onog qobo naafanimatha ku hooseyta IDEA). Iskoolka degmatha may sithoo kala ka warsatha koree waqta kasta haddii atha fathaasa inii onogaa laku qiimeeya hubnoo shaqaalaga degmatha oo an maleeyi inii onogaa an baahatha koro ta'liin kaas eh. Midshoo haalada, kudib markii iskoolka hela ogolaanshagaa (ogolaanshaga) oo qoraal haan eh, may buwaa inii ka dhammaaya qiimeynta (koowaad) 60 gee oo kaleendarka eh dhatiyee.

Haddii Onoga eyi Qeebta Gobolka

Haddii onoga eyi **qibta gobolka** ii an la noolayna waalid kii shee ama waalidshee, iskoolka degmatha man ku baahan ogolaansha waalidka oo qiimeeyowka koowaad eh ee laka go'aansathow haddii onoga eyi onog naafa eh ee haalathoo higaan ka jara:

- Haddii, inkastoo dadaalo ma'quul eh saas suubiyaasa, iskoolka degmatha ma weydiyi korto waalidka onoga;
- Haquuqoo waalidka wal roojiyi; ama
- Haquuqoo waalidka may lan hilsaareey garsoora oo shaqsi oo ogolaadi qiimeynta koowaad.

Qiimeeyowka Walbarashada Gooniga eh (IEE)

Qiimeynta Walbarashada gooniga eh (IEE) saas oo kala may lanka weereey meel ku bahsan qiimeynta. iskoolka degmatha yaa biyaasa qiimeynta banaanka eh haddii marhore laka suubiye qiimeyntiye qaske eh bas eh oo athana diida walaa degmatha heleen. Ujeedatha may buwaa helowka baahiyatha onogaa ee Walbarashada qaske eh, ama joogteeya inii an baahatha ta'liin qas eh. Qofka qiimeeyaw onogaa ee qiimeyntun banaanka eh man shaqeyya korto iskoolka degmatha onogaa. Atha, sithii waalid may haq an leyaa, waqta kasta, inii diyaariya ama ku biyi qiimeynta banaanka onogaa. Markii atha diida qiimeynta degmathaa ee onogaa oo warsoy qiimeynta banaanka, degmathaa may laku fathey inii qaadatha tallaabooyinka iyee oo an jarna daahow muhiim an hayna:

- iskoolka degmtha may buwaa inii kiinsheega meela atha ku hela korto qiimeynta banaanka ee onogaa ee iqtiyaarshey eh oo haka ogeysiya sharuuda muhiim n eh degmatha inii biitha iyee. Markii degmatha ogolaata oo athana hela qiimeynta banaanka, degmatha may laku fathey inii biitha qarashaadka; ama
- Degmatha may laku fathey inii ka hareyta odsaga Hafiiska Walbarashada Laanta Ohio oo Ardayda la ogolaatha Koro oo dhagunsiga shariga adaalada (fiiri baalka 21) sababtoo eh mat ka diidey odsagaa oo qiimeeyowka banaanka eh. Tan may sabab an nagathaase inii degmaatha an malayta qiimeyowshey qaaska eh ee onogaa ka filinayti.

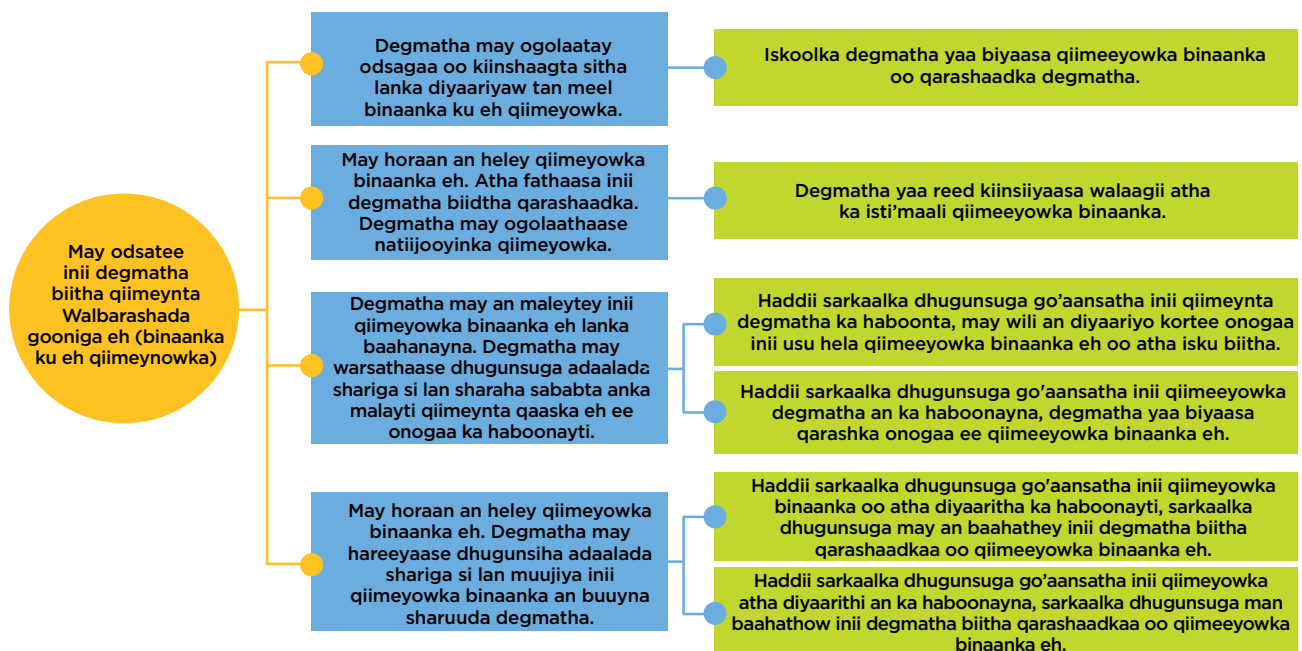
Sharuuda oo Qiimeeyowka Banaanka ku eh

Isla sharuuda ee quseyta qiimeeyowka inii degmatha suubitha saas oo kala may quseystee qiimeeyowka banaanka eh ee waaladiinta diyaariyaan oo degmatha yaa biyaasa iyee. Sharuudun may ka jaree meela onogaa qiimeeyowka an baha ii waaya aragnimatha qofka wal baaraw onogaa. Degmaatha may laku fathey inii biitha qarashaadka buuha ee qiimeeyowka banaanka eh ee buuya sharuuda degmaatha.

Haddii atha odsata qiimeeyowka banaanka eh ee onogaa, degmatha may ka warsatha **kortee** sabata atha anka diidi qiimeeyowka degmatha ee onogaa (taas may buwaa, sababoo an fathaasa qiimeeyowka banaanka eh), laakin mal an baahan inii atha fafaahitha tan illaa atha fathaasa ina sithaas suubitha. May bas eewaa haq an latee too banaanka ku eh qiimeynta biithi degmatha, oo waqta kasta degmatha qiimeyta onogaa oo athana ka diida natiijooyinka qiimeynta degmatha.

Markii onogaa hela qiimeyn banaanka eh oo buuyaasa sharuuda degmatha, oo lan ku fiirana dadka biyaw iyee, degmatha may tihgeliyaasee natiijooyinka qiimeyntaas oo go'aansathaasa sithii ansiyaasa onogaa ta'liin bilaash eh oo ka haboon (FAPE).

Iskoolka degmatha may laku fathey inii kasiya ogeysiin qoran (lan weeraw ku hor ogeysiin qoran) ee guthoo tira ma'quul eh oo waqtaga ku hor intii hanjeethina ama an diidna inii qaathan tallaabooyin qaarshoo. Tallaabooyinkun may ka jaree degmatha bilaabaasa ama badelaasa aqoonsiga, qiimeeyowka ama meeleyowka Walbarashada ee onogaa ama biyowka Walbarashada bulshada oo bilaashka eh ee onogaa. Ku hor ogeysiinta qoran intii lan baahana foomka Walbarashada qaaska eh.

Tusmooyinka Ogeysiiska Qoran ee Hore

Ku hor ogeysiinta qoran may buwaa inii sheegta sharahaad ka filan oo kin ogolaathaasa inii atha ku qiihgala go'amatha atheegoo Walbarashada onogaa ee qab aathi eh. Gaarhaan, ku hor ogeysiinta qoran maybuwaa inii ka jarta tusmooyin qaas eh, sithii laka sheegi sanduuqa la jarti ee baalkun eh.

Ku hor Ogeysiinta Qoran may buwaa Af Lafahama Koro

Ku hor ogeysiinta qoran may buwaa inii laka sheega af fahama koraan bulshatha guud ii saas oo kala may buwaa inii ka qoranaata afka asalka eh ama qaab kala oo hiriirka illaa si ed an wal tar anka lahayna suubiyowshee.

Haddii afka asalka waalidka ama qaabka kala ee hiriirka **an** hayna af qoran, kudib degmatha may an baahantaa inii tallaabooyin qaada oo af haan lanka fasiraw ku hor ogeysiinta qoran, ama qaab kala oo la fahamaw, oo afka asalka waalidka ama qaab kala oo hiriir eh. Degmatha may an baahathaasee inii hubiitha inii ka muujiya korta, qoraal haan, inii ku hor ogeysiinta qoran lanka fasirna si ka haboon ii inii waalidka fahamaw tusmooyinka.

Ku hor Ogeysiinta Qoran May buwaa inii ka Jarta:

- Sharahaadka tallaabada la hajeediyi ama diideen degmatha;
- Sharahaada oo sababta degmatha han jeedidi ama an diidi inii tallaaba qaathan;
- Sharahaada nithaamka dabagalow kasta, qiimeeyowka, diiwaanka ama wargeliyowka iskoolka isti'maalaw si an suubiyaan go'aanshoo;
- Qoraalka oo waalidka leyii illaalatha sitha quseyta nithaamka illaalatha IDEA's , ii haddii ogeysiiyowka an hayna gudbiyow hora oo qiimeeyowka, qaababka ee waalidka an hela koraan sharahaadka nithaamka illaalatha;
- Illoo waalidka han la hiriiraayaan aawiyow oo fahamowka sharuuthoo IDEA;
- Sharahaadka dooqyatha kala koothta IEP tihgeliyeen ii sababoo dooqyathaas lan diithi;
- Sharahaadka haqiiqoo kala oo quseeyaan ha jeediyowka degmatha ama diidmatha.



Diiwaanatha Walbarashada

Diiwaanatha La hala koro

Heerka Haquuqoo Walbarashada Qoyska ii Arimoo qaaska eh (FERPA) may buwaa shariga faderaalka ee siiyaw waalidka haquuqoo qaaska eh oo laka baaraw oo laka fiiriyaw diiwaanatha Walbarashada ariinyoo. Haquuqoo quseeyaan wareejiyowka FERPA ee waalidka illaa kutaabta markii kutaabka deera 18 sanno jar ama bilaaba ku qiibgalowka iskoolka sara (tusaala haan, kueejka ama jaamada), koo kasta oo ha hormara.

May Iyiin Diiwaan gelinta Walbarashada ?

1. Haddii aqbaarta qaarshoo ee quseeya kutaabka ilaaliyaan FERPA may ki hirantaa Haddii sheyka buuya mi'naaaga diiwaanka ta'liinta. FERPA may ka qeehaasee diiwaanatha Walbarashada sithii: Diiwaanatha sitha toos eh an la hiriiraan hal kutaab qaas eh. Mararka qaarshoo dugsiyada may anka weeraana aqbaarta qaaska eh ee la aqoonsatha karo; ii
2. Diiwaanatha hayaan hay'ada Walbarashada ama ma'hadka (tusaala haan, iskoolka degmatha) ama hisbiga matalaw hay'adaas.

Hayowka ama Asturnaanta Diiwaanatha

Diiwaanatha Walbarashada may laka joogteeya koree qaabab badan.

Tusaalooyinka qaar may buwaa:

- Galan qorowka;
- Daaba'awka;
- Kumbiyuutarka;
- Fiidiyowka ama ajalada dhugunsuga; ama
- Filimka, ajalada filimka ama qiibta simman ee filmika.

Diiwaanatha kutaabta may buwaa qarsootha, mi'na shey eyi inii **qaas eyin**.

Iskoolka degmatha ama hay'ada may laku fathey inii illaaliyaan arimoo qaaske eh ee diiwaanatha onogaa markii aruuriso, keydisa, dhiida ama baabi'iitha iyoo.

Fiiriyowka Diiwaanatha Onogaa

Iskoolka degmatha may laku fathey inii kiin ogolaatha inii atha fiirisa diiwaanada aafimaadka onogaa iyee on an jarna daahow muhiim an hayna ii ku hor kulunka koohta IEP ee kasta ama da'awada adaalada shariga ee atha la lugleta. Degmatha ma suga korta wal ku badan 45 maalmood ee ku bilow taariigta odsagaa si kiinka ogolaata inii atha fiiritha diiwaanatha.

May haq an lettaa inii atha fiiritha bas eh aqbaarta ka jarta diiwaanka ee quseeya **onogaa**. May lettaa haquuqtah laka warsathaw iskoolka sharahowka diiwaantah onogaa. May haq an lettaa inii atha kiila jara qof, oo atha ka matalow, baaraw diiwaanatha (sitha saahibka ama looyarka).

Degmatha may ka siiya kortee koobiyatha diiwaanatha onogaa; si kastaba haatoo degmatha **waa inii** kisiitha koobiyatha Haddii laka guuldareysatha suubiyowka sidaas may koo hor surumaasee ka dhagamowka haquuqdhaha oo atha ka fiiryaasa diiwaantha. Markasta may haq an lettaa inii atha hela koobiyatha diiwaanatha ee qaarshaadkaa eh.

Aqbaarta Shaqsi haanta Lan aqoonsatha koro may ku mid ataa:

- Magaaga onogaa;
- Magaaga hubnooga qoyskaa;
- Iwaanka onogaa ama iwaanka reerka;

Roojiyowka

Roojiyowka may la mi'na eyaa roojiyowka arimoo Ashtako gobolka. Haddii atha ama iskoolka degmatha ka lugletin dhugunsuga adaalada shariga, ii midhsoo atha ama degmatha saas oo kala hareeyaan Ashtako gobolka ee isla arimoo, Laanta Walbarashada Ohio may geliyaasee Ashtako gobolka roojiyow. Mi'naga kala, Laanta may sugaasee illaa adaalada shariga dhammaata ku hor intii lan haliina abashada gobolkaa. Haddii atha ku laabata odsagaa dhugunsuga adaalada shariga, Laanta may ku suubiyaasee Ashtako gobolka roojiyowka oo sii wathaasa haliyowka Ashtakoa.

Haddii dhugunsuga adaalada shariga dhiitha oo go'aanka ee sarkaalka dhugunsuga qiiibta eh (IHO) la suubiya, ku dib Laanta may ku biyaasaa Ashtako gobolka roojiyowka si lan haliyi bas eh Haddii arimoo wili ke hereen Ashtakoa oo hor lanka go'aansana hiliga sarkaalka dhugunsuga.

Nithaamka Ashtako Gobolka

Markii Laanta hela abashadaa gobolka, Haddiiba si ka haboon lan hareeya, may bilaabaasee fiiriyowshey ii, sitha muhiimka eh, baar hadgudubyatha lahaka eedeeyi ee sharuuthoo Walbarashada qaaska eh. Hafiiska Ardayda Qaaska eh waa inii laka haliyo Ashtako 60 maalmood dhatiyee oo ku bilaabathaasa taariiqga iyee hela abashadaada.

Sitha qiib ku eh nithaamka Ashtako, Hafiiska Ardayda Qaaska eh may:

- Fiiriyaayaana Ashtakoo oo go'aansathayaan Haddii leyiin ogolaanshaga laka haliyow eedeymaha Ashtakoo;
- An sheeg lamathaba atha iskoolka degmatha oo qoraal haan ee eedeymaha haliyaasa, oo ka jaraan baarowka (Haddii lan ku maaran);
- Sii dhahdhahaathiyow ama fudutheyow oo lamathaba eh atha ii degmatha sitha qaab kala oo laka haliyow Ashtako;
- Warsoy walaagii aqbaar dheeraad eh ee laku yaaba inii an ku baahata atha ii degmatha oo quseeya eedeymaha Ashtakoo;
- Fiiriba dokumentidheeda dheeraad eh oo aqbaarta atha biithi ii degmatha, suubiyowka wareysiga mobeelka oo booqoy degmatha onogaa, sitha go'aansathaasa inii muhiim eta;
- Sii degmathaa fursada lanka jawaabow Ashtakoo oo sii haliyowka; ii
- Qor haanshida ogeysiyaasa lamathaba athi ii degmatha go'aanshey ee quseeya hadgudub Walbarashada qaaska eh dhiithi (kudib dhammaasirowka fiiriyowshow ii baarowshoo, Haddii muhiim an hayna, oo an ku bathamnayna 60 gee oo kaleendarka ee taariiqda heleen Ashtakoo).

Kordhiyowka Wokhtiga

- Atha ii iskoolka degmatha ogolaataan waqta bathan si markaas lamathiinba inaska deythaan inii ka halithaan dhibaataatha dhiniga dhahdhahaathiyowka, fudutheyowka ama qaabab kala ee haliyowka qilaafka kale; ama markii
- May jaree haalathoo qaaska eh (ee go'aansatha Hafiiska Ardayda Qaaska eh ee si ka saleysan da'wad-ba-da'wadn).

Buyowka An ka hoobayna

Haddii Hafiiska Ardayda Qaaska eh go'aansathan inii si ka haboon anka hareyna Ashtako gobolka sababtoo eh maka darna aqbaarta muhiimke ah oo dhan ee quseeya arinta atha fathaasa inii la haliyi, ama Haddii Hafiiska Ardayda Qaaska ehan haysana ogolaanshaga laka baarow Ashtako, Hafiiska ee Ardayda Qaaska eh may hakiin direy haanshi sharahaasa: May hor an ka dareerna haliyowka Ashtakoo, sababgta go'aankun ii, Haddii quseyta, aqbaarta atha an baahanta inii atha ka darta Ashtako usub ee iyee lanka tihgeliyow hareeyow buuha.

Reed an hareeyowka Ashtako

Haddii eta inii atha reed gudbiitha Ashtako aqbaar usub, hubsoy inii atha an darta Ashtako Laanta Walbarashada Ohio ii iskoolka degmatha ee gudoo hal sanna ee markii dhiithi eedeeyowka hadgudubka Walbarashada qaaska eh. Haddii atha ka darti arimoo Ashtakoo inii Laanta an lahayna ogolaanshaga laka haliyow, may lakin gudbiyey illoo laka sheegow arimoogun, sitha ka haboon.

Hareeyowka Ashtako

- Ashtako ka hareysan guthoo hal sanna ee hadgudubka laka eedeeyi.
- Waalidka may siiyay orijinaalka Laanta Walbarashada Ohio ii koobi degmatha eh.
- Ashtako eetheyasa hadgudubka ee sharuuthoo Walbarashada qaaska eh oo la jaraan haqiqoo taageeraayaan.

Laanta Walbarashada Ohio yaa Fiiriyaasa Ashtakooyin

- Laanta may an diraayaanaa haanshi qorasha eh shaqsiga hareeyi abasha ii iskoolka degmatha.
- Laanta Walbarashada Ohio yaa diraasa haanshi an ka filanayna Haddii Ashtako si anka haboon lanka buyna, ama Haddii Laanta an lahayna ogolaanshaga laka haliyaw.

Haliyowka

- Laanta yaa fiiriyaasa dhammaan dukumintiyaasha oo odsatha dukuminti/ aqbaar dheeraad eh sitha lanka baahatha.
- Laanta yaa Wareysathaasa shaqsiyaadka quseeya, sitha lanka baahatha.

Laanta May an diraasee Haanshida Natiijooyinka

- Laanta may suubiyaasee go'aamiyowka quseeya eedeeyn kasta ii Haddii jaraan hadgudubowka Walbarashada qaaska eh.
- Laanta yaa suubiyaasa tallaabooyinka sahawka meela oo degmathana laka heli inii ka hadgudubti.



Buuyowka Ashtako Adaalada Shariga

Hal qaab oo waalidka ka haliyi koro walwalka quseeya Walbarashada qaaska eh ee onogshoo oo la jaraan iskoolka degmatha may buwaa hareeyowka odsaga ee dhugunsuga adaalada shariga oo toos an ka dareerta degmatha, iyee oo koobiga hor lanka gudbiyaw Laanta Walbarashada Ohio. Markii atha tan suubitha, may hareyey Ashtako adaalada shariga (saas oo kala lan kasaw odsaga adaalada shariga). May jareey haan kala oo hareeya koraan Ashtako adaalada shariga:

- Kutaabta, Haddii anka yaraan 18 sanna jar;
- iskoolka degmatha; ama

Hay'athoo Walbarashada bulshatha.

Sababoo lan Hareeyaw

Ashtako adaalada shariga may lan hareeya koree walaa'yatha ka lugleh aagaga higgan ee Walbarashada qaaska eh ee onogaa:

- Aqoonsiga onoga qobo naafanimatha;
- Qiimeyowka onoga qobo naafanimatha;
- Meeleyowka Walbarashada ee onoga qobo naafanimatha; ama Deersiiyowka Walbarashada bulshatha ka haboon ee bilaashka eh (FAPE) ee onogaa.



Ashtako adaalada shariga waa inii ka eedeeya faderaalka ama gobolka sharuuthoo Walbarashada qaaska eh laka hadgudubi oo waa inii laka buuya guddoo **lama sanna** ee taariigta waalidka (ama hay'ada Walbarashada bulshatha ee hareeyaasa Ashtako) ogsanyi ama ama waa inii ogaatha wal quseeya hadgudubka Walbarashada qaaska eh ee laka eedeeyi arinta. Markas oo Laanta Walbarashada Ohio hela Ashtako dhugunsuga adaalada shariga, waalidka ii iskoolka degmatha ee ka lugleh waa inii helaa fursada lanku qiihgalow dhagunsiga adaalada shariga. Dhugunsuga adaalada shariga may buwaa da'wad rasmi eh oo sarkaalka dhugunsuga dhahdhahaadka eh an hilsaarti Laanta si an suubiya dhugunsuga laka haliyaw Ashtako adaalada shariga.

Aqbaarta laka Daraw

Laanta may biyaasee qaabka lan isti'maala koro inii laka odsatha dhugunsuga adaalada shariga. Qofka ama hay'ada Walbarashada bulshatha ee gudbiyaasa odsaga mal an baahan inii isti'maalaan [foomka Laanta](#), laakin qofkaas ama hay'ada waa inii wili ka dartaa aqbaartun lan baahanyi markii gudbiyaasa Ashtako adaalada shariga:

1. Magaaga kutaabka;
2. Iwaanka kutaabka ama aqbaarta hiriirka;
3. Magaaga iskoolka degmatha;
4. Haddii onogaa man laan eyi, aqbaarta hiriirka lan hela koro onogaa ii magaaga iskoolka onogaa dhikathaw;
5. Sharahaadka dhibaataha qaaska eh ee la hiriirta obogaa, sithoo kala sitha haqiiqoo quseeyaan dhibaataha; ii
6. Afkaaroo ama hajeethiyowka laka haliyaw dhibaataha.

Ashtako adaalada shariga waa inii wathataa isku midka, aqbaarta sharahan sithii Ashtako gobolka (fiiri baalka 18), si kastaba sahih orijinaal eh mal an baahan. May la deersiiya koree iskoolka degmatha ii Laanta oo qof haan eh, oo boosto haan, fakis ama i-meel. Arimoo an ka jarna Ashtakoo adaalada shariga ma fiiriyaw sarkaalka dhugunsuga intii laka jara dhugunsuga adaalada shariga.

Badelowka Ashtakada Adaalada Shariga

Badelowka abashada adaalada shariga may usbooneysiyaasee Ashtako markii horaan lanka gudbiyi Laanta Walbarashada Ohio. Badela korto Ashtakoo adaalada shariga bas eh Haddii:

- Hisbiga kala ogolaatha Ashtako adaalada shariga la badelay, oo qoraal haan, ii may la siiyey fursada laka haliyaw Ashtako illaa kulunka haliyowka (kulunka haliyowka may laka sharahey baalka 23); ama
- Sarkaalka dhugunsuga dhahdhahaadka yaa siiyee ogolaanshaga. Sarkaalka dhugunsuga may biya koree ogolaansha noo'aas eh oo illaa shan gee ku hor dhugunsuga adaalada shariga an bilaabana, laakin ma eh taas kudib.

Jadwalka waqtiga ii Nidaamka Adaalada Shariga

Haddii atha hareyta Ashtako adaalada shariga ee haku horjeeda iskoolka degmatha onogaa, oo 10 gee oo kaleendarka ah dhatiye ee helowka Ashtakoo adaalada shariga, degmatha waa inii ka siitha ogeysiyoowka qoraalka ku hor ama jawaabta la hiriirta eedeeyowka hadgudubowka Walbarashada qaaske eh, illaa degmatha horaan an biithi ogeysiin noo'aas eh (fiiri baalka 9). Ku hor ogeysiinta qoran inii degmatha ka siithi waa inii ka jaraan:

- Sharahowka tallaabatha inii odsagaa ama Ashtako quseyta. Tan may naqatha kortee tallaabatha degmatha fathaasa inii usta ama tallaabatha iyee diidi inii qaathata. Degmatha saas oo kala waa inii ka sharahtaa jawaabtiyoo sababta iskoolka an fathaayi inii tallaabatha an qaatha ama an diithi inii tallaabatha qaatha;
- Sharahowka oo dhammaan qaababka iyee isti'maali inii laka qiimeeya onogaa, diiwaanatha quseeya onogaa ii wargeliyowka degmatha isti'maali si an suubitha go'aanshey laka qaathow tallaabatha ama lan qaathaana tallaabatha;
- Sharahowka dooqyatha kala koothta IEP may tihgeliitey inii onogaa ii sababoo sababta an diidi dooqyathaas; ii
- Sharahowka haqiiqoo kala ee la hiriiri go'aanka degmatha ee tallaabatha ka qaathaasa ama an ka qaathaana.

Iskoolka degmatha saas oo kala waa inii ka siiyi aqbaarta la hiriirta gargaarka shariga bilaashka eh ama qiimaga hooseeya ii atheegoo kala ee la hiriiraan ee atha hela korta.

Haddii ashtako adaalada shariga la hareeya ee atha hakoo horjeeda sithii waalid, waa inii an ku jawaabta Ashtako 10 gee kaleendarka dhatiye. Jawaabta waa in si gaar ah lan sheegaa arimoo laka sheegi ashtako adaalada shariga.

Ka fillan

Ashtako adaalada shariga may lan tihgeliyey inii ka filinya (mi'nashey eyi inii si ka haboon la buuyi) **illaa** hisbiga kala ogeysiya lamathaba sarkaalka dhugunsuga dhahdhahaathiyowka ii hisbiga gudbiyi Ashtako ka eetheeyaasa inii an buuyaana sharuuthoo buuyowka (tusaala haan, inii anka filanayna). Hisbiga kala waa inii la tartamaa ku filnaanshaga Ashtako adaalada shariga, oo qoraal haan eh, 15 gee kaleendarka dhatiye eh ee markii Ashtako adaalada shariga la heli.

Tusaala haan, haddii atha hareyta Ashtako adaalada shariga ee degmathaa eh (ii an gudbiitha koobiga Laanta Walbarashada Ohio), may lan tihleiyey inii ka filanta illaa degmatha ogeysiitha sarkaalka dhugunsuga, oo qoraal haan ii 15 gee dhatiye, taas maka fikiraasa inii odsagaa si ka haboon lan buuyi. Kudib, sarkaalka dhugunsuga may leyaa shan gee oo kaleendarka eh oo ku bilaabathaasa markii usu ama iyee helaan ogeysiyoowka qoran ee degmathaa si lan go'aansatha haddii ashtakoo adaalada shariga ka filanta (taas may buuyaasee sharuuthoo ashtako adaalada shariga ee laka aqoonsathi baalka 21). Sarkaalka dhugunsuga saas oo kala may buwaa inii hasiin diraan go'aansheey ama go'aankiishee atha ii degmatha, oo qoraal haan, 15 gee dhatiyoo.

Haddii sarkaalka dhugunsuga go'aansatha inii ashtakoo adaalada shariga ka filanta, may letaa iqtiyaarka oo midshoo reed lanka hareeyow abasha usub ee adaalada shariga ama la badelaw ashtako hore ee adaalada shariga, haddiiba degmatha an ogolaati oo leta fursada laka haliyaw haalada oo illaa kulunka haliyowka ama sarkaalka dhugunsuga siiyi ogolaanshaga an ku dambeyna shan gee ku hor bilawka dhugunsuga.

Haddii atha si ka haboon an badela ashtakoo adaalada shariga, kudib muddada haliyowka 30-gee eh (fiiri baalka 23) oo bilaabathaw markii atha hareyta ashtako la badeli.

Muddatha Haliyowka

Muddada haliyowka may buwaa muddada waqtaga oo an dhaheya buuyowka ashtako adaalada shariga ii dhugunsuga runta eh ee adaalada shariga. Muddada haliyowka may ka lug lettaa kulanka haliyowka oo siyaasa fursad, halkoo kala, oo reed lanku haliyow qilaafka Walbarashada qaaska eh ku hor intii dhugunsuga si rasma eh an ka bilaabana. Haddii atha hareyti Ashtako adaalada shariga laakin markaas kudib ka guuldareysati inii atha ku qiihgala nidaamka haliyowka, tan may daahiyaasee bilowka waqtaga adaalada shariga (oo wal bathan jadwalka waqtaga hoosa).

Muddada haliyowka may buwaa 30 gee oo ku bilaabathaasa taariigta ashtako adaalada shariga la hareeyi (ama ku bilaw taariigta Ashtako si sah eh lan badeli). Haddii iskoolka degmatha an haliina ashtako adaalada shariga oo atha ka qana'santa oo waqtaga 30 gee dhaafta, dhugunsuga adaalada shariga sii dareera korto. Markii 30-gee ee muddatha haliyowka dhammaata, may jarey 45-gee waqtaga oo dhugunsuga adaalada shariga ii sarkaalka dhugunsuga dhahdhahaadka eh si go'aan an deera (fiiri baalka 24), illaa atha ii degmatha iska rataan dhahdhahaathiyowka oo dhaafaw 30 gee. Saas oo kala la dareer 30-gee ee muddada haliyowka eh may dhammaata kortee waqta hora haddii, intii laka jara 30 gee, atha ii degmatha ka heliithaan qoraal haan inii heliis suurtoagal ah hayna.

Intii laka jara 30-gee ee muddada haliyowka, ii 15 gee ee kalneedarka anka horeyta ee ku bilaabathaasa helowka Ashtako adaalada shariga, iskoolka degmatha waa inii balamiyaa kulunka haliyowka. Haddii degmatha an qobona kulunka haliyowka 15 gee oo kaleendarka eh dhatiyee ama anku qiihgala kulunka haliyowka, may odsatha kortee sarkaalka dhugunsuga si an bilaaba 45-gee ee jawadlka waqtaga adaalada shariga. Degmatha mal unka baahan inii balansathaan kulunka haliyowka Haddii laka hareeya ashtako adaalada shariga.

Kulunka Haliyowka

Ujeedka kulunka haliyowka may buwaa ka siiyowka fursada lan ku hathalaw dhibaatooyinka ee Ashtako ii iskoolka degmatha hela fursada atha la kiila shaqeeyaw dhinayaalka haliyowka. Masuuliyada may saarantaa degmatha si lanka weera kulunka haliyowka, oo may lakoo fathey inii ku qiihgala. Haddii atha an ku qiihgala kulunka haliyowka oo degmathana kin qorta ku qiihgala la'aantaa, degmatha may warsatha kortee sarkaalka dhugunsuga inii ku tanaasulu ashtako adaalada shariga dhammaatka muddatha 30-gee eh.

Atha ii iskoolka degmatha yaa go'aansathey kaas oo hubnool koothta IEP eh inii ku qiihgalaan kulunka haliyowka. Kulunkun waa inii ka jaraan wakiilka iskoolka degmatha oo an leh ogolaanshaga go'aamatha lanka deeraw degmatha.

Looyarka degmatha maku qiihgalaan kulunkun illaa atha ku doorata inii looyarkaa meelaas rooga. Kulunkun may buwaa tallaaba lanku baahanyi nidaamka haliyowka illaa atha ii degmatha anka heliithaan qoraal haan inuu ku bataan kulunka haliyowka ama atha ii degmatha may ogolaateena inii isti'maalaan dhahdhahaathiyowka diyaarsan ee kulunka haliyowka. Atha ii degmatha may la sin ogolyaa muddatha haliyowka 30-gee Haddii isin lamiathin ogolaataan inii saas suubithaan. Tan may ku horseethaasee 45-gee ee dhugunsuga adaalada shariga ii jadwalka waqtaga go'aanka oo bilowke eh.

Haddii atha ii degmatha haliithaan qilaafaadkaa ee kulunka haliyowka, lamathin waa si shari eh an sahiithaan heliiska ka hirin ee:

- Oo hor an dajiyaw walaagii haddadhiyooya oo qoraal haan eh;
- May sahihaayaana lamathinba atha ii wakiilka degmatha; ii
- Mahklamada may fulliya kortee.

Shari haan qaababka ka hirin oo Haddii atha ama iskoolka degmatha anka hogaansanayna heliiska, inii mahkamad an baahatha korto midshoo atha ama degmatha inii saas suubiyi.

Haddii midshoo atha ama iskoolka degmatha go'aansatha inii an ogolayna, sahihowka heliiska kudib, lamathin koo shoo yaa ka roojiyi koro heliiska sadi gee shaqa dhatiyoo oo sahihowka ku bilaabathaw sahiha.

Haddii atha ama iskoolka degmatha deera heliiska Ashtako adaalada shariga qiyaastii ku hor 30-gee ee muddada haliyowka dhammaata, Ashtako al hiree oo m jaraasa dhugunsuga adaalada shariga oo la suubiyaw.

Dhugunsuga adaalada shariga waa in la balamiyaa oo laka suubiyaa goobta ii saa'ada oo ma'quulka atha ii iskoolka degmatha ka haboon. Sarkaalka dhugunsuga dhahdhahaadiyowka yaa hakiila hiriirey atha ii degmatha isla waqtaga markasta oo hiriirka lan baahatha intii laka jara nidaagmka dhugunsuga. Mi'naga kala, dhammaan hiriirka dhehari sarkaalka dhugunsuga dhahdhahaadiyowka, atha ii degmatha yaa watha diyey oo si goona ma eh.

45-gee ee jadwalka waqtaga dhugunsuga adaalada shariga (oo sarkaalka dhugunsuga dhahdhahaadiyowka si go'aan an deera) may bilaabathaase 30-gee ku dib muddada haliyowka markii dhammaata ama markii ko kan kumid eh dhiyaan:

- Atha ii degmatha may qoraal haan ka ogolaateena inii isku dhaaftaan (inii an halna) kulanka haliyowka; ama
- Markii atha bilawta ku hadalowka arinta oo kulunka haliyowka eh ama kulanka dhahdhahaathiyowka, atha ii degmatha may qoraal haan ka ogolaateena inii wal heliis eh suuragal an hayna; ama
- Atha ii degmatha may qoraal haan ka ogolaateena inii dhaaftaan 30-gee muddada haliyowka si markaas an sii wadda inii dhahdhahaadiska, ii kudib midhsoo atha ama degmatha ku laabatan nidaamka dhehdhahaadiyowka.

Illaa sarkaalka dhugunsuga dhahdhahaathiyowka ogolaatha inii waqta bathan siiya (ama mi'naga kala, ka siiya kordhiyowka), oo odsaga oo koo kumid eh dhiniyaalka oo 45-gee jadwalka waqtaga dhugunsuga, haan higa yaa dhiyaan:

- Dhugunsuga waa in la qabothaa;
- Go'aanka dhugunsuga waa in la deeraa; ii
- Koobiga go'aanka waa in lanka dira lamathaba boosta la haqijiyi atha ii dugisga, saas oo kala sitha Laanta Walbarashada Ohio.

Anka yaraan shan gee ku hor dhugunsuga adaalada shariga, atha ii iskoolka degmatha waa inii ku qiibgalaan dhiyowka shirka. Kan may buwaa watha sheekeysiga laka hubiyaw inii lamthaba atha ii degmatha haytaan aqbaarta lahaka dhikaw dhugunsuga.



Dhugunsuga Adaalada Shariga may Suubiyay Sarkaalka Dhugunsiga Dhahdhahaathiyowka

Markii Ashtako adaalada shariga lan haliya korna, may an hogaamiyaasee dhugunsuga rasmiga eh oo suubiyi sarkaalka dhugunsiga dhahdhahaadiyowka. Sarkaalka dhugunsuga waa inii nanqathaa qareenka tababareen Laanta Ohio ee Walbarashada si lan suubiyi dhugunsuga adaalada shariga.

Iskoolka degmatha yaa biyey qarashka sarkaalka dhugunsuga, si kastaba shaqsigun dhahdhahaathu, oo hisbi sadahaad eh. Usu ama iyee man shaqeeyaayaan iskoolka degmatha ama hay'ada kala ee bulshatha ee kulug leh Walbarashada oo may laku yaabee inii an lahayna dana shaqsiyeed ama hirid eh oo anku hiiliyaw hal dhini dhiniga kala.

Intaas may dheera, sarkaalka dhugunsuga eethaa lanka ka see sharuuthoo Walbarashada qaaska eh, oo ka jaraan IDEA, shariyatha fadseraalka ii gobolka ii heerarka oo sitha mahkamathoo an fasiraayaan da'wathoo Walbarashada qaaska eh.

Dhugunsuga kudib, sarkaalka dhugunsuga yaa qorey go'aanka la hiriira dhaqanka shariga aathiga eh. Degmathaa ama ama Laanta Walbarashada Ohio may siiya kortee liiska saraakiisha dhugunsuga ii shahaadooyinka kala, ama may ku hela kortee liiska atha oo fiiriyaasa [education.ohio.gov](https://www.ohio.gov), oo weydiyaasa erayga furaga eh, *saraakiisha dhugunsuga adaalada shariga*.

Haquuqoo Dhagunsiga

Dhugunsuga adaalada shariga, may haq an letaa inii:

- Haysata onogaa kaas oo eh sababta dhugunsuga lan qobothaw;
- Odsaga inii dhugunsuga an furunaathaw bulshatha;
- Haysata looyarkaa ama dadka kala ee leh ilmiga qaaska eh ee Ardayda naafatha oo kiila taliyaan;
- Adeynta la sheeni (adeynta), marqaataga hor kooyaw ii baaritaanka guud (su'aaloo) oo an baahan ku qiibgalowka marqaataga (markala, dhugunsuga may sheegey bas eh arinta atha ka sheegti Ashtakoo adaalada shariga, illaa degmatha ogolaata inii atha sheegta arin usub);
- Mamnuu'a adeyn kasta oo la sheeni oo atha la kin tusna an ka yaraan shan gee shaqa eh dhugunsuga ku hor; ii
- Oo atha beesa laan kii eh, hel qoraalka eray-ka-eray, ama Haddii atha doorbithaasa koronto, diiwaanka dhugunsiga, ii diiwaana kasta ee natiijooyinka ii go'aamatha.

Haddii Kiila Jaraan U dootha Kasta oo An hayna Looyar

Haddii kiila jaraan u dootha kasta oo an hayna looyara, shaqsiyaadkun man qalamaw inuu hela qidmooyinka looyarka (looyarka) (ama qidma kasta oo atheegithiyoo eh) oo ku kooyaw hisbiga kala. An doodaga maka dhaqama koro dhugunsuga ii ka qiibgalowka an doothaga hadidnaatha korto intii laka jara da'wada.

Ha dadajiyowka Ashtakooyin ii Jadwalka waqtaga Adaalada Shariga

Dhugunsuga adaalada shariga oo laha dadajiyi maybuwaa dhugunsuga leh jadwalka waqtaga degdege eh oo futhutheeyaw haliyowka degdega eh ee qilaafaadka Walbarashada qaaska eh qaarshoo. Midshoo atha ama degmatha may gudbiyi kortaana odsaga ee dhugunsuga adaalada la dadajiyi ee haaladoogun bas eh Haddii:

1. Atha ka diida go'aanka iskoolka degmatha ee quseeya meeleeoyowka Walbarashada onogaa (barnaamijka ama atheegoo), ii tan may haytey natiijatha iskoolka edbiyooya onogaa; ama
2. Atha ka diida natiijatha ee go'aamiyowka muujiyowka; ama

iskoolka degmatha may aaminsanyaa meelooyowka Walbarashada onogaa ee hadda(barnaamijka ama atheegoo) may buwaa si hoogan oo an dhow inii ka sababta dhaawa' onogaa ama dadka kala. Jadwalka waqtaga Ashtako adaalada shariga oo laha dadajiyi may ka jarey muddada haliyowka 15 gee kaleendarka ii jadwalka waqtaga Ashtako ee 20 gee dugsi eh. Iskoolka degmatha waa inii ka balamiyaa kulunka haliyowka todobo maalmood oo kaleendarka gudushoo oo helowka Ashtako adaalada shariga. Kudib dhugunsuga adaalada shariga oo laha dadajiyi dhammaathi, sarkaalka dhugunsiga may leyaa 10 gee dugsi eh oo laka qorow go'aan anka dambeeyi oo atha ii degmatha la siinsiyaw. Ma jaraan waqta dheeraad eh oo laka daraw intii laka jari ashtako adaalada shariga.



Ra'faan ku qaadathowka Go'aanka

Go'aanka suubiyi sarkaalka dhugunsuga dhahdhaathiyowka ee gabagabatha dhugunsiga adaalada shariga maybuwaa waqtaga anka damboyti illaa hisbiga murugeysan si toos eh an gudbiya ra'faanka oo la jaraan Laanta Walbarashada Ohio oo 45 gee dhatiyoo ee helowka go'aanka. Hisbiga murugeysan midshoo may buwaa waalidka ama degmatha markii go'aanka sarkaalka dhugunsiga anka faylahayna hisbiga (taas oo mi'nashey eyi inii hisbiga anka guuleysana).

Sitha Lan ka ra'faan Qaathathow Go'aamoo Sarkaalka Dhugunsiga

Si lanka ra'faan qaadata go'aanka sarkaalka dhugunsiga, waa inii an dirtaa koobiga ra'faankaa oo qoraal haan eh Laanta ii koobiga ra'faanka muraaqibka ee iskoolka degmathaa. Laanta may maga'aawey sarkaalka fiiriyowka heerka gobolka (sarkaalka fiiriyowka) si lan suubiyi fiiriyowka dhahdhahaadka ee go'aanka adaalada shariga. Laanta Ohio ee Walbarashada yaa biyaasa sarkaalka fiiriyowka. Sarkaalka fiiriyowka yaa baaree diiwaanatha dhugunsiga adaalada shariga. Intaas may dheera, sarkaalka fiiriyowka may hubiyey inii dhugunsuga rahi sharuuthoo adaalada shariga oo weydiiy adeyma dheeraad eh sida lan araga inii muhiim eta. Sarkaalka fiiriyowka may odsatha koree murunka afka ii qoran oo atha koo kooyi ii iskoolka degmatha. Haddii sarkaalka fiiriyowka suubiyi dhugunsiga laka tihleiyaw murunka afka eh, dhammaan haquuqoo dhugunsuga (fiiri baalka 25) oo atha lakinka hela koro dhugunsuga adaalada shariga wal kiin awootha kora intii laka jara dhugunsiga.

Si lan Odsatha Ra'faanka Go'aanka Sarkaalka Dhugunsiga Dhahdhaathiyowka

May diitha kortee go'aanka sarkaalka dhugunsiga dhahdhaathiyowka (ra'faanka) oo qoraal haan eh 45 gee dhatiyoo ee helowka go'aanka. Haka dir ra'faankaa:

Kordhiyowka/Waqtaga

30 gee dhatiyoo ee kudib markii Laanta hela odsagaa ee fiiriyowka heerka gobolka, sarkaalka fiiriyowka may suubiyey go'aanka, illaa usu ama iyee la siiya kordhiyowka, kaas oo laku odsatha koro midshoo waalidka ama degmatha (si kastaba, qoraalka ee kordhiyowka waqtigaas mal biyi koro intii laka jara ra'faanka ku kooyi dhugunsiga adaalada shariga). May sithoo kala an odsatha kortee koronta haan ama koobiyatha qoran ama diiwaanatha korontatha eray ku eray ee natiijooyinka ii go'aanka fiiriyowka sarkaalka.

Ku ra'faan Qaadathowka Mahkamada Faderaalka ama Gobolka

Go'aamoo fiiriyowka heerka gobolka may buwaa kii an ka dambeeyi illaa lanku ra'faan qaadata mahkamada faderaalka ama gobolka. Hisbiga an farahsanayna (taas maku horsuramaw) fiiriyowka go'aanka sarkaalka may haq an leyaa inii hareeya da'wada e mahkamada faderaalka degmatha oo 90 gee dhatiyoo ee ku bilaabathaasa taariigta fiiriyowka go'aanka sarkaalka ama mahkamada qirathowka aadiga eh ee wadanka ee iskoolka degmatha onogaa ee dadka dagan may ka yaalee 45 gee dhatiyoo ee helowka ogeysiinta go'aanka sarkaalka fiiriyowka. Mahkamada may fiiriyaase diiwaanatha, dheegaayaan adeyn bathan ee odsaga hisbiyatha oo suubiya go'aanka anka dambeeya oo quseeya diiwaanatha ii adeynta la sheeni. Waa inii bithaa qarashaadka mahkamada ee ra'faanka atha ka hareyti mahkamada laakin, Haddii atha ka guuleysati, may an qalama kortee qidmooyinka mahkamada ii qidmooyinka qareenka (fiiri baalka 28) ee iqtiaarka mahkamada.

Heerka Onoga ee intii Laka jara Adaalada Shariga

- Onogaa waa inii ka hera ama roogowka meeleyowka Walbarashada haddaiyee oo Ashtako adaalada shariga dareera, illaa atha ii iskoolka degmatha ogolaatha inii meeleyowka Walbarashada onogaa isbadela korto. Meeleyowka Walbarashada haddaee onogaa may buwaa kan laka sheegi meeleyowshee haddaanka dambooyi ee fulliyeen IEP.
- Haddii onogaa laka meeleyi goobta Walbarashada kala ee ku meeldeerka eh (IAES – goobta Walbarashada ku meeldeerke eh oo ku bahsan iskoolka) sababtoo eh edbiyowka ee iskoolka degmatha eh, onogaa may roogey goobtaas Walbarashada illaa sarkaalka dhugunsiga suubiya go'aanka ama illaa edbiyowka degmatha ee onogaa dhammaata, too kasta oo dhiitha tan koowaad; Haddii ashtako adaalada shariga ka lugleyi ogolaanshaga degmatha, onogaa, oo la jaraan ogolaanshagaa, waa inii laka laka meeleya degmatha illaa nidaamka adaalada la dhameesira.
- Haddii Ashtako adaalada shariga ka lugleta inii odsaga bilaaba atheegoo sitha quseyta sannatha iskoolka oo qiib ku eh shariga sababtoo eh onogaa may deerey 3 sanna jar oo markala man qalamaw atheegoo sitah quseyta wal tarka hora oo shariga qiib ku eh, iskoolka degmatha man baahan inii biyi atheegoo walqabadka hora ee onogaa an helaana.
- Haddii onogaa lan hela inii an qalama atheegoo Walbarashada qaaske eh ii waalidka ogolaathan biyowka hora ee atheegoo, kudib iskoolka degmatha waa inii siya atheegyathaas qilaafka an ka jarna oo an dhaheeya waalidka ii degmatha.
- Haddii sarkaalka fiiriyow la ogolaatha waaladiinta onogaa inii isbadelowka meeleyowka ka haboonyi, meeleyowka waa inii lan la dhagamaa sithii heliiska an dhaheeya gobolka ii waalidka oo ujeedatha roogowka.

Qidmooyinka Looyarka

May dooratha kortee inii kireysata looyarka (looyarka) oo waqti kasta oo atha kii matalaw adaalada shariga (ama da'watha ee ra'faanka ee go'aanka adaalada shariga), laakin waa inii bithiitha qarashaadka shariga. Haddii atha doorata inii kireysata looyar oo athana ka guuleysata (hela go'aan faa'itha leh) oo tallaaba kasta ama da'wada la hiriirta dhugunsugaa adaalada shariga (oo koo dhikaw hisbiga ku hor seethaw), mahkamada may ka amara kortee degmatha inii ka siitha qidmooyinka looyarka ma'quulka eh.

Haddii Degmatha ka Guuleysata

Haddii degmatha ka guuleysata, mahkamada may amara kortee inii atha biitha qidmooyinka looyarka ma'quulka eh ee degmatha. Mahkamada may kii amara kortee atha ama looyarkaa inii biithaan qidmooyinka looyarka ee Laanta Walbarashada Ohio ama iskoolka degmathaa Haddii iyoo ka guuleysataan oo mahkamadana go'aansata haan ha dareeraan:

- Inii tallaabatha hayti too dhab an hayni, ma'quul an hayna ama aasaas an lahayna;
- Inii atha sii wada inii atha sheenta tallaaba shari kudib markii tallaabatha si ed an nagata too dhab an hayna, ma'quul an hayna ama aasaas an lahayna; ama
- Inii tallaabatha lan sheeni ujeeda anka haboonayna, sithii dhibaateeyowka, sababowka daahow muhiim an hayna, ama kordhiyowka lanka baahanayna qarashka qidmathaa shariga.

Haddii Mahkamada Amarta Qidmooyinka Shariga inii Reed Lan kiinsiya Atha ama Degmatha

Haddii mahkamada amarta qidmooyinka shariga inii reed lakiin siiya atha ama degmatha, mahkamada may go'aansathaase tirada ma'quulka eh. Qidmada qareenka waa inii ka saleysnaatha qiimooyinka aathiga eh ee bulshaatha meela oo tallaabatha ama da'watha la sheeni ii noo'a ii tayatha adeegyatha la biiyi. May jartee hadeeyow qaarshoo ee kartitha mahkamada ee laka abaalmaryow qidmooyinka looyarka.

Mahkamada ma abaalmaryi korto qidmooyinka oo haaladoogun eh:

- Meela oo degmatha ka suubiyaasa qorowka ee laka haliyow qilaafka ee guthoo 10 gee ee da'wada, ma ogolaathaasa siiyowka ee 10 gee dhatyoo, ii hukumowka haalada eethaa an wanaag yarta atha badelkii haliyowka la hajeethiyi ee degmatha biithi;
 - Si kastaba, mahkamada may kiin abaalmaryi kortee qidmooyinka atha Haddii atha ka guuleysati tallaabatha oo mahkamada go'aansati inii si hoogleh lan adeeyi (leyi sabab fayle) an ogolaathaana haliyowka degmatha biithi;
- Ku qiihgalowka looyarathaa ee kulunka IEP illaa kulunkaas lan weera sitha sababti dhugunbsiga maamulka ama tallaabatha mahkamada; ii
- Oo ku qiihgalowka looyarkaa ee kulunka haliyowka.

Yareeyowka Qidmatha Looyarka

Mahkamada may sithoo kala yareeya kortee abaalmaryowka qidmooyinka looyarka Haddii:

- Intii laka jara haalada da'watha, atha ama looyarkaa si ma'quul eh an daahithaan halka an ka dambeeya ee qilaafka eh;
- Tiratha qidmooyinka looyarkaa si ma'quul an hayna yaa anku sareyta qiimooyinka saa'adlaaga kaas oo eh qiimaga laka guuleysati ee bulshatha oo atheegoo lamidka eh ee looyarka leh hifada an dhiganta ee ma'quulka eh, sum'ada ii waaya aragnimatha;
- Waqtaga la isti'maali ii atheegoo shariga ee atha heli may haytey had dhaaf (eed an bathan) ee la siiyi noo'a tallaabatha ama da'wada;
- Looyarkaa maka siina aqbaar ka haboon iskoolka degmatha ogeysiinta abashahathaa.

Ma jaraan wal koro oo quseeya Haddii mahkamada hela inii gobolka ama iskoolka degmatha si ma'quul an hayna an ku dayta halka anka dambeeya ee tallaabatha ama da'wada ama Haddii kala ka hadguduba illaalatha badbaadatha IDEA.

Haalathoo qaarshoo, iskoolka degmathaa may laku fathey inii joogteeya siiyowka atheegoo Walbarashada qaaska eh onogaa naafatha eh, hittaa kudib markii degmatha roojitha, ku buriiitha ama haddii kala ku saarta onogaa meelis Walbarashada hadda(tihraa' IEP onogaa walaagii aqbaar dheeraad eh ee meelis ama meeliyee Walbarashada hadda).

Meeleeyowka Walbarashada ii Badelka

Haddii onogaa lanku saara meelis ama meeliyee Walbarashada haddaoo ka hadgudubowka shariyada iskoolka degmatha oo wal ku yar 10 gee dugsi oo iska higta, degmatha mal an baahan inii siitha onogaa atheegoo Walbarashada qaaska eh intii laka jara wokhtigaas. Haddii onogaa laku saara iskoolka *wal ku badan 10 gee dugsi oo iska higta*, iskoolka waa inii joogteeyaa siiyowka onogaa atheegoo Walbarashada qaaska eh, hittaa haddii eta goob ta'liin kala (tusaala haan, fasal kala, dhismaga, ama manka kutaabka).

Haddii iskoolka degmatha ku saara onogaa meelis ama meeliyee haddaoo in ku bathan 10 gee dugsi iska higta ee isla sannatha iskoolka, may lan tihgeliyey isbadelka meeli Walbarashada onoga.

Haddii iskoolka degmatha ku saara onogaa ee meelis ama meeliyee ee Walbarashada haddaee dha'thooyin qaas eh (ku saarow dhab eh) ee ka daraw illaa wal ku bathan 10 gee ee sannatha iskoolka, iskoolka waa inii go'aansathaa Haddii ku saarowkaas ku koobanyi badelka meela Walbarashada onogaa. Suubiyowka go'aamiyowka, degmatha waa inii tihgeliithaa haqiiqoo higaan:

- Baahada wokhti kasta ee onogaa laku saari;
- Tiratha guud ee waqtaga onogaa laku saari;
- Sithee eed anka dhaw ku saarowka hayti; ii
- Sitha la midka eh dabee'ada onogaa ee dabee'adiis ama dabee'adiyee ee dha'dooyinka hora ee onogaa laku saari.

Markii la badelaw meela Walbarashada onoga sababtoo eh onogaa ma rana shariyatha iskoolka, iskoolka degmatha, waalidka ii hubnoo quseeyaan ee koohta IEP waa inii buyta muujiyowka fiiriyowka go'aanka. Ujeedka muujiyowka fiiriyowka go'aanka may buwaa go'aansiga haddii dabee'ada onogaa sababti ama leta hiriir toos eh oo muhiim an eh naafanimatha onogaa.



Muujinta Go'aanka

Ku hor intii atha an badelna meela Walbarashada onogaa oo sababoo naafanimatha, iskoolka degmatha waa inii suubiyaa tallaabooyinka qaarshoo ee laka illaaliyay haquuqta onogaa. Hal tallaaba may buwaa suubiyowka kulunka muujiyowka fiiriyowka go'aanka. Kan may buwaa kulunka laka go'aansathaw haddii dabee'ada onogaa sababti ama leta hiriir toos eh oo muhiim an eh naafanimatha onogaa. Mi'naaga kala, dabee'ada onogaa sababtey naafanimathiisa ama naafanimathiyeey? Koohta kutaabka IEP yaa go'aansarthaasa Haddii dabee'ada onogaa sababti ama an sababna naafanimatha ee 10 gee dugsi gudashoo ee go'aan kasta ee laka badelaw meeleeeyowka ta'liinta.

Fadlan Ogow

Onogaa may quseeyee isla shariyatha ii edbiyowka sithii kutaab kasta ee iskoolka oo may sii wathaayaana inii helaan atheegoo laka sheegi IEP, laakin laku yaaba inii an hayna isla meela.

Kulunka Fiiriyowka Go'aanka Muujiyowka

Kulunka fiiriyowka muujiyowka go'aanka, atha ii hubnoo kala ee koohta IEP aqbaarta fiiriyowka la hiriirta oo ka jaraan IEP onogaa, kormeerowka ma'alanka oo aqbaar kala ee la hiriirta oo laka siiyi.

Haddii muujiyowka dabee'ada ee naafanimatha onogaa, onogaa may laka nagey meeleeeyowka ku kooyaw oo usu ama iyee laku saari, illaa koohta IEP ogolaathan inii badelaan meeleeeyowka.

Haddii dabee'ada onogaa laku hela inii muujiyaasa naafnimatha, koohta IEP waa inii:

1. Ka bilaabaan qiimeeyowka shaqatha dabee'ada 10 gee dhatiyeey oo buyta sitha anka dhaqsitha bathan oo suurtogalka eh. Qiimeeyowka shaqatha dabee'ada may buwaa fiiriyow dabee'ada onogaa kaas oo lan isti'maalaw inii laka go'aansatha walaa, jawiga onogaa, ki'yaalka dabee'ada an ka haboonayna, saas oo kala sitha oo tan dabee'ada meeleeeyowka an baahan inii la bara marka onogaa may heley natiijooyin fayle ii jawaab; ii
2. Bilaaba qorshaga wal qobothowka dabee'ada Haddii qiimeeyowka dabee'ada shaqatha hor lan dhamaasiri oo la hiriirta edbiyowka galanta eh. (Qorshaga wal qabathowka dabee'ada may sheegey dabee'ada an ka haboonayna iskoolka ii qaababka qaaska eh ee iskoolka may iska dayey inii yaraaya iyoo.); ama
3. Haddii wal qabathowka qorshaga dabee'ada horaan an jari, fiiri qorshaaga oo suubi badelowka kasta ee lanka baahatha 10 gee dhatiyoo.



Go'aanka lanka meeleeeyaw onogaa goobta Walbarashada badelka ku meeldeerka (IAES) may suubiyey koohta IEP ee onogaa. IAES may buwaa ku meeldeer, meeleeeyow shal duwan ee onogaa si an hela ta'liin qaas eh. Taariigta koohta IEP suubitha go'aanka laka badelaw meeleeeyowka onogaa ee IAES sababtoo eh onogaa may ka hadguthubey shariga iskoolka, iskoolka degmatha waa inii ka ogeysiyaan go'aanka oo ka siiyaan Jaheeyowkun ee Haquuqta Waalidka ee Walbarashada Qaaska eh. Hittaa haddii dabee'ada onogaa sababti naafanimatha onogaa, degmatha may ku saara kortee onogaa IAES oo illaa 45 gee dugsi eh Haddii onogaa qobo:

- Wadatha hub;
- Atha oo og haysata ama isti'maalaasa darooga shari dara eh, ama gathaasa ama iska dayti inii atha gathata ama gata maandooriyaha hakameysan (tusaala haan, muqaadaraadka); ama
- Walyeelaga dhaawa'a jirka halista eh oo qof kala.

Tan guud haan may quseytee haddii onogaa ka dhagama dabee'ada usu ama iyee an dareeraan ama haku dareeraan iskoolka, iskoolka ama shaqatha iskoolka.

Haddii dabee'ada onogaa **oo si toos eh anka sababna naafanimatha onogaa**, onogaa may laka meeleeeya koree IAES oo isla tiratha ee waqtiga ee inii onoga an qobna naafanimatha waa la edbinayaa.

Haddii atha ii degmatha diidaan wal quseeya badelka meeleeeyowka, degmatha may ka warsatha kortee dhugunsiga adaalada shariga la dadajiyi - mi'naaga kala, may ka warsatha kortee dhugunsiga adaalada shariga oo markii la dabagalaw oo haliyow degdeg eh (Fiiri adaalada shariga la dadajiyi ee baalka 25).
